6. MANDATORY STANDARD TERMS AND CONDITIONS

6.1 Mandatory Accident Protocol & Repair Restrictions: In the event of any accident, impact, collision, theft, dashboard warning light, or mechanical failure, the Renter MUST notify RKT Global Pty Ltd IMMEDIATELY. The Renter strictly agrees that they SHALL NOT attempt to fix, repair, adjust, tinker with, body-fill, paint, or arrange any third-party maintenance on the vehicle themselves under any circumstances. All repairs must be authorized and executed solely by an official service facility approved in writing by RKT Global Pty Ltd. Unauthorized repair work will void all insurance protections and the Renter will assume full personal civil liability for the complete cost of proper professional restoration, engineering testing, and subsequent commercial loss-of-use.

6.2 Permitted Use & Geographic Restrictions: The vehicle must only be driven on sealed, gazetted public roads within the approved state/geographic boundaries. Driving off-road, on beaches, unsealed access roads, river crossings, or fire trails is strictly prohibited. Sub-hiring, passenger-sharing, or using the vehicle for commercial courier/delivery networks (unless pre-authorized in writing), racing, towing, or any illegal activity is completely barred.

6.3 Authorised & Licensed Drivers Only: The vehicle must only be operated by the specific drivers named in this Agreement. All drivers must maintain a current, unrestricted, valid driver's licence corresponding to this vehicle category throughout the complete rental term. Operation by unauthorized, learners, or suspended drivers completely voids the insurance cover.

6.4 Fuel Policy & Cleaning Requirements: The vehicle is provided with a specified fuel level and must be returned matching that exact level (e.g., Full-to-Full). A refuelling charge at premium localized commercial rates plus a \$50 admin fee applies for deficiencies. The van must be returned clean; specialized commercial cleaning fees (\$150 minimum) apply to spills, cargo stains, or commercial waste left behind.

6.5 Traffic Infringements, Tolls & Infringement Processing Fees: The Renter assumes full financial responsibility for all toll charges, parking fines, speeding tickets, and traffic law violations incurred during the rental window. Every infringement processed by the Owner will attract a mandatory \$55 administrative handling fee in addition to the fine amount.

6.6 Rental Extension & Late Return Policy: Any extension of the rental tenure must be requested at least 24 hours prior to the scheduled return time and is subject to written approval and current vehicle availability. Late returns without written authorization will be billed at double the standard daily rate plus a late return administration fee.

6.7 Liability, Indemnity & Governing Law: The Renter comprehensively indemnifies RKT Global Pty Ltd against all actions, losses, property damage, bodily injury, claims, or punitive legal expenses arising directly from their rental or possession of the vehicle. This legal instrument is governed entirely by the courts and laws of New South Wales, Australia.
